O R D E R 11/03/2022

- 1. The petitioner has filed his RTI petition before the PIO of Gauhati University on 3.1.2022 seeking some following information:
 - (a) Please furnish whether Gauhati University has ever taken programmes to regulate of foundation level courses from Pre-primary classes to Class X through any Model School/ME School (English Medium, Assamese Medium,Hindi Medium) to conduct examinations and other academic activity from its own resources/funds during the period 2014-15 to till date, if yes please furnish following details:
 - (i) Please furnish in details of school wise yearly expenditure was made to conduct examination and other academic activity of above said period and copy of bill, receipt and voucher along with under which Act, permitted for expenditure borne its own resources/funds to conduct said activity.
- 2. In reply to that, the PIO of Gauhati University sent a letter vide no. GU/PIO/RTI/2022/650 dated 1.2.2022 to the petitioner furnishing his sought for information.
- 3. On not being satisfied with the information received, the petitioner filed complaint petition u/s 18(1) of the RTI Act,2005 before the Commission on 7.2.2022. Accordingly, the matter was taken up for hearing.
- 4. The petitioner Sri Joydeb Das is present.
- 5. The Public Authority is represented by Dr. Prasanta Barman, Deputy Registrar & PIO of Gauhati University and he is accompanied by Sri Dhrubajyoti Sahariah, Professor & Secretary, GU Model School Management Committee.
- 6. On perusal of the complaint petition as well as reply of the SPIO it seems that there is a communication gap, however, the Commission accepts it and disposes the case.
- 7. <u>The Commission directs the petitioner to give specific question with reference, if</u> <u>he wants to do so and he is free to file complaint petition if he does not get the</u> <u>reply as per the Act.</u>
- The case is disposed off.
