O R D E R
14/03/2022

1. In continuation of earlier order dated 8.3.2022, the matter was taken up for hearing.
2. The petitioner Sri Joydeb Das is present.
3. The Public Authority is represented by Sri Suryya Kamal Bora, SPIO of Directorate of Welfare of Scheduled Castes and he is accompanied by Sri Liton Mitra, Deemed PIO, Directorate of Welfare of Scheduled Castes, Dispur.
4. The petitioner verbally stated that following information are yet to be given:-
 - (a) No. Of agriculture kits distributed till date and date on which fund released to the supplier and copy of work order with allocation with copy of contract agreement , comparative statement of price bid and minutes of the price bid during the period 2019-20 and 2020-21.
 - (b) What was the procedure followed prior released of payment to the supplier as well as Govt. Sanction guideline with copy of file noting regarding release of payment.
 - (c) Specific information regarding list of beneficiaries APRs.
 - (d) Name of the selection committee member and procedure followed selection of beneficiary.
 - (e) Specific information whether any audit query has raised or not till date because involvement of fund is common taxpayer money.
 - (f) Copy of affidavit during the period 2020-21.
 - (g) Sample verification which was submitted by the awarded/non awarded bidders in bid.
5. The SPIO and Deemed PIO have mentioned that on 17.3.2022 they have fixed a date for inspection and supply of the documents to the petitioner.
6. To this the petitioner said that there is nothing to inspect, however he needs copies of the documents.
7. In light of the above, the Commission directs the SPIO and Deemed PIO to provide specific information to the petitioner on 17.3.2022.
8. The petitioner to remain present and sort out the issue whether records given are to his satisfaction or not.
9. In view of the above, the case is conditionally disposed off.
