**O R D E R**  
**11/03/2022**

1. The petitioner Sri Harinarayan Pathak has filed one RTI petition before the SPIO, O/o the Managing Director, Guwahati Smart City Ltd. on 4.10.2021 seeking following information:
  - (a) Name in full of the SPIO, First Appellate Authority in the O/o the Managing Director, Guwahati Smart City Ltd. being designated u/s 5(1), 5(2) and 19(1) respectively of RTI Act, 2005 with validity as on 4.10.2021 in documentary proofs.
  - (b) Action taken reports in documentary proofs in terms under sub clause nos. VIII till XI of Clause B of Section 4 of the RTI Act, 2005, with validity upto 4.10.2021 w.e.f., date of establishment of the public authority i.e., Guwahati Smart City Ltd.
  - (c) Date of establishment of the public authority, namely Guwahati Smart City Ltd. In documentary proof of the Official Assam Gazette Publication.
  - (d) Copy of the Act under which the Public Authority, as referred to at the query no. 3 above has been notified.
2. Accordingly, information was furnished to the petitioner on 1.11.2021 by the SPIO of Guwahati Smart City Limited.
3. On not being satisfied with the information received, the petitioner filed 1<sup>st</sup> appeal before the 1<sup>st</sup> Appellate Authority, Guwahati Smart City Limited on 8.11.2021 and after that there was a hearing at the Office of Guwahati Smart City Ltd. on 25.11.2021 where the petitioner was present and some information was given to him.
4. In the meantime he filed 2<sup>nd</sup> appeal before the Commission on 31.1.2022 and accordingly the matter was taken up for hearing.
5. The Public Authority is represented by Ng. Chandra Dhvaj Singha, OSD & SPIO, Guwahati Smart City Limited.
6. The SPIO has submitted a written statement dated 11.3.2022 which is taken into records. From the written statement it is seen that some additional information has also been furnished to the petitioner.
7. The petitioner Sri Harinarayan Pathak is absent.
8. The Commission accepts the written statement of the SPIO of Guwahati Smart City Limited and disposes the case.
