1. The petitioner Sri Jitu Kakati has filed one RTI petition before the Public Information Officer, Assam Fishery Development Corporation, Mahapurush Madhavdev Path, Chachal, Guwahati on 18.11.2021 seeking following information:
 - (a) Details of the name, address, educational qualification, caste certificate of all the engineers working in the office of Assam Fisheries Development Corporation, VIP Road, Guwahati. Please furnish a list of the same and details of necessary departmental rules and regulations regarding the appointment of those working engineers.
 - (b) Kindly furnish the order copy passed by the Authority regarding appointment and promotions of working Executive engineer and Additional Executive Engineer working in the Office of Assam Fisheries Development Corporation.
 - (c) Please furnish a list of various schemes/projects implemented by Assam Fisheries Development Corporation Ltd from 1.1.2018 to till date in various (Meen Mahals). Please mention the name of schemes/project, sanctioned amount, advance or amount paid till date including date and names and address of mahaldar/contractor in the list.
2. On non receipt of any information, the petitioner filed 1st appeal before the 1st Appellate Authority, Assam Fisheries Development Corporation Ltd. Chachal, Guwahati on 23.12.2021 and then he filed 2nd appeal before the Commission on 2.2.2022.

Accordingly the matter was taken up for hearing.

3. The petitioner Sri Jitu Kakati is present.
4. The Public Authority is represented by Sri Deisaulungbe Pame, SPIO & Junior Technical Manager.
5. On perusal of the records, it is found that reply has been given to the petitioner on 24.2.2022. The petitioner said that in some aspect reply is incomplete and some of the photocopies are not legible.
6. In warning the SPIO for his failure to furnish the information within stipulated time, the Commission orders that petitioner should visit the office of SPIO on a convenient date and collect the remaining information including the legible copies.

The SPIO to facilitate in the whole process.

7. In view of the above, the case is disposed off.
