O R D E R

1. The petitioner Sri Alok Shankar Das has filed one RTI petition before the Director General of Police, Ulubari on 21.06.2021 seeking following information:
 - (a) Whether the case of the applicant for compassionate appointment has been placed before the Chief Secretary to the Govt. Of Assam for consideration as per order dated 8.2.2021 passed by the Hon'ble Gauhati High Court passed in WP(C) NO. 657/2021.
 - (b) Whether the case of the applicant for compassionate appointment has been considered by the State Level Committee for compassionate appointment, Govt. Of Assam, for consideration as per order dated 8.2.2021 passed by the Gauhati High Court passed in WP(C) No. 657.2021
 - (c) Details of information required: Please provide the copy of communication letter and copy minutes of SLC where the petitioner's case is considered.
2. In response to that, the information was provided to the petitioner vide letter dated Guwahati 29.11.2021.
3. After that the petitioner filed 1st appeal before the 1st Appellate Authority, DGP, Assam Ulubari on 1.12.2021 even without appreciating the reply given by the SPIO on 29.11.2021.
4. The reply to 1st appeal petition was submitted by the SPIO but the same was returned by the Postal Department stating that address is not found.
5. The petitioner then filed 2nd appeal before the Commission on 14.2.2022 and accordingly the matter was taken up for hearing.
6. The petitioner is present.
7. The Public Authority is represented by Sri Ashim Kumar Dey, Deputy S.P. and he is authorised by the Assistant Inspector General of Police(A) & PIO, Assam, Ulubari, Guwahati vide letter dated Guwahati 21.3.2022.
8. The Deputy S.P on behalf of the PIO mentioned the facts which is already stated in the written statement vide no. G(RTI)/VI/141/2021/24, dated Guwahati 21.3.2022.
9. The Commission accepts the written statement and disposes the case.
