O R D E R

1. The petitioner Sri Joydeb Das has filed one RTI petition before the PIO, Gauhati University, Guwahati on 3.1.2022 seeking following information:
 - (a) Please furnish in details of the list of advance payment was given from Gauhati University fund (other than from Provident Fund) to Vice Chancellor/Professors/Lecturers/Officers/Officials of the Gauhati University during the financial year 2014-15 to till date.
 - (b) Please furnish whether advance payment has been returned to the GU Account, if yes, please furnish details of advance returned and pending till date.
2. On 22.1.2022 the Deputy Registrar of Gauhati University sent a letter to the petitioner wherein it is mentioned that the RTI petition is forwarded to the Treasurer of Gauhati University. In the meantime the Office of the Treasurer has asked for some more time to furnish the information, as they have to deal with many files.
3. The petitioner then filed a complaint petition u/s 18(1) of the RTI Act, 2005 before the Commission on 28.1.2022 and accordingly, the matter was taken up for hearing.
4. The petitioner Sri Joydeb Das is present.
5. The Public Authority is represented by Dr. Prasanta Barman, Deputy Registrar & PIO, Gauhati University and he is accompanied by Prabhash Chakravarty, Asstt. Treasurer, Gauhati University.
6. The Deemed PIO stated the problem of voluminous documents which he has already mentioned in the earlier letter dated 22.1.2022.
7. However, in era of computerised documents, the information regarding a few 100 persons should not take much time.
8. In light of the above and taking request of Deemed PIO/PIO into consideration, the Commission allows one month time to compile the information and furnish the information in soft copy/ hard copy format to the petitioner.
9. The case is disposed off.
