O R D E R

- 1. The petitioner Sri Joydeb Das has filed one RTI petition before the PIO of Assam Agricultural University, Jorhat, Assam on 29.11.2021 seeking following information:
 - (i) Whether AAU has purchased new vehicle during the period June 2017 to June 2018, if yes, please furnish following details:
 - (a) Please furnish department wise list of vehicle purchased with price and furnish procedure following prior purchase of new vehicle (copy of all the relevant document).
 - (b) Please furnish what procedure adopted regarding departmental existing old vehicle prior purchase of new vehicle (copy of all the relevant documents) and list of department wise old vehicle condemnation along with copy of Govt. Approval for procurement of new vehicle.
 - (c) Please furnish a copy of MOU between the Govt. Of Assam and AAU dated 18.3.2006.
- 2. On receipt of part information, the petitioner filed a complaint petition u/s 18(1) of the RTI Act,2005 before the Commission on 14.2.2022 and accordingly the matter was taken up for hearing.
- 3. The petitioner is present.
- 4. The Public Authority is represented by Sri Anup Kumar Das, PIO & Joint Registrar (Academic), Assam Agricultural University, Jorhat. The SPIO has submitted a written statement dated 21.3.2022 which is taken into records.
- 5. The petitioner intimated that he has received the information to his satisfaction.
- 6. Since the information is received, the case is disposed off.
