O R D E R

- 1. The petitioner Smti Rinki Bharti has filed one RTI petition before the PIO of DC Office, Tinsukia on 30.6.2021 seeking some information on Tinsukia Development Authority.
- 2. On 8.7.2021, the PIO of DC Office Tinsukia forwarded the RTI petition to the Chairman of Tinsukia Development Authority, Tinsukia with a direction to furnish the information to the appellant within stipulated time.
- 3. In the meantime, the petitioner filed 1st appeal before the 1st Appellate Authority, O/o the Deputy Commissioner, Borguri, Tinsukia on 24.8.2021. The 1st Appellate Authority then passed an order on 23.9.2021.
- 4. The petitioner then filed 2nd appeal before the Commission on 17.1.2022 and accordingly, the matter was taken up for hearing.
- 5. The petitioner is absent without any intimation.
- 6. The Public Authority to be represented by SPIO, O/o the Chairman, Tinsukia Development Authority, Tinsukia is absent. However, the PIO has sent an email dated 22.3.2022 wherein he has sought for two weeks more time to give the information to the petitioner.
- 7. The Commission accepts the prayer and directs the PIO to furnish the information to the petitioner within stipulated time.
- 8. In view of the above, the case is disposed off.
