## O R D E R

- The petitioner Md. Mozafar Hussain has filed one RTI petition before the Office of District Agricultural Officer, Darrang, Mangaldai on 3.11.2021 seeking three nos. of information.
- 2. The petitioner then filed 1<sup>st</sup> appeal before the 1<sup>st</sup> Appellate Authority, O/o the District Agricultural Officer, Darrang on 5.12.2021 and then he filed 2<sup>nd</sup> appeal before the Commission on 10.1.2022.

Accordingly, the matter was taken up for hearing.

- 3. The petitioner is absent without any intimation.
- 4. The Public Authority is represented by Dr. Manoranjan Sarma, SDAO, District Agricultural Office, Darrang cum SPIO and he is accompanied by Sri Bidyut Kr. Talukdar, SDAO, District Agricultural Office, Darrang cum Ex SPIO.
- 5. The SPIO has submitted a written statement dated 17.3.2022 stating that the information has already been provided to the petitioner.
- 6. The SPIO intimated that the petitioner visited the office on 17.3.2022 and got the necessary documents with proper receipt.
- From the above, the Commission concludes that the behaviour of the petitioner is irresponsible as he has not intimated this Commission about the receipt of the information.

Had he intimated the Commission probably the SPIOs should not have been called for the hearing.

The Commission would like to keep a record of petitioner's callous/irresponsible behaviour for future reference.

**8.** In view of the above, the case is disposed off.
