ORDER 27-01-2022

1. Due to the prevailing Covid pandemic situation, the hearing was held through telephonic conference.

- 4. The Commission has received a written statement dated 24.01.2022 from the Executive Director, National Health Mission, informing that the informations sought by the appellant Shri Jalil Khan have been provided.

A proof of delivery of the information shall also be provided to the Commission.
