- 2. The appellant Shri Debendra Nath Adhikary is absent. But he has authorized one Shri Lokamanash Adhikary to attend the hearing today on his behalf. Accordingly, Shri Lokamanash Adhikary is physically present in today's hearing. He has submitted a letter of authority duly signed by Shri Debendra Nath Adhikary, along with photocopy of his I-Card (Aadhar Card) as proof of identity.
- 3. Shri Pranjal Baruah, SPIO and Circle Officer, Barpeta Revenue Circle, is present through teleconference.
- 4. From records it is seen that Shri Debendra Nath Adhikary had submitted one RTI application to the SPIo, O/o the Barpeta Revenue Circle, on 04.12.2020 seeking two informations (i) copy of documents related to correction of records of land under Dag No. 978 Patta No. Eksana 149 of Sundaridia Koloyahati village of Barpeta Mouza under order No. 257/10-11 for Namzari issued by the Circle Officer and, (b) Copy of application on the basis of which the Circle Officer had issued orders No. 36/2016-17/Part dated 01.12.2016 pertaining to land under Dag No. 978 of Aeksona 149 of Sundaridia Koloyahati village of Barpeta Mouza.
- 5. During today's hearing the SPIO/Circle Officer, Shri Pranjal Baruah stated over telephone that the above two documents are presently not traceable in his office but he informed that those could be available in the Deputy Commissioner's Office, Barpeta.
- 6. In view of the above, the SPIO/Circle Officer, Barpeta Revenue Circle, is directed to do the needful and trace the two documents in the Deputy Commissioner's Office, Barpeta, copies of which the appellant Shri Debendra Nath Adhikary had sought and furnish them to him within 21 (twenty-one) days from the receipt of this order. The SPIO/Circle Officer shall also inform the Commission about the furnishing of the information immediately on expiry of the 21 (twenty-one) days period. He shall also provide the Commission proof of delivery of the informations duly acknowledged by the appellant.
- 7. With the above order, this 2nd Appeal is hereby disposed of.
