O R D E R 17/03/2022

- 1. The petitioner Sri Joydeb Das has filed his RTI petition before the PIO of Gauhati University, Jalukbari, Guwahati on 3.1.2022 seeking following information:
 - (a) Please furnish in details of the statement of an amount which was Fixed Deposited by the GU in bank during June 2014 to till date, along with details of interest earned and details of expenditure incurred.
- On 4.2.2022 the petitioner received a reply from the Deputy Registrar & PIO of Gauhati University and on 14.2.2022 the petitioner filed a complaint petition u/s 18(1) of the RTI Act,2005 before the Commission stating that proper information is not yet provided to him deliberately.

Accordingly, the matter was taken up for hearing.

- 3. The petitioner Sri Joydeb Das is present.
- 4. The Public Authority to be represented by SPIO, O/o the Registrar, Gauhati University, Jalukbari is absent. However, he has sent an email dated 16.3.2022 stating that due to his other engagement in other official work he is unable to attend the hearing.

However vide his written statement dated 14.3.2022 he has requested the Deemed PIO i.e., Treasurer of Gauhati University to remain present.

The Deemed PIO is absent without any valid reason.

- 5. The Commission has decided to hear the matter again. Issue notice to Deemed PIO by name and PIO to remain present and clarify the reply.
- 6. Fix next date of hearing.
