**O R D E R**  
**17-01-2022**

1. The hearing was taken up over the telephone on conference due to the prevailing covid situation. Appellant Shri Waris Alam Ansari and Shri Rituraj Bordoloi, SPIO & Circle Officer, Bihpuria Revenue Circle attended the hearing through tele-conference.
2. The Circle Officer had vide letter No. BC.58/Part/2018/43 dated 12.01.2022 informed the Commission that the informations sought by the appellant Shri Waris Alam Ansari have been already furnished vide letter No. BC.54/Part/2018/43 dated 07.05.2021. A copy of the information provided vide the above-mentioned letter has been also submitted by the Circle Officer along with 2 (two) other letters.
3. The appellant Shri Waris Alam Ansari however said that though he had received some portions of the informations sought (which he has duly acknowledged by putting his signature on the Circle Officer's letter dated 07.05.2021), he has not received copy of minutes of a particular SDLAC meeting along with copy of Kobula application, agenda list etc. Responding to this, the SPIO & Circle Officer, Shri Rituraj Bordoloi pointed out that the minutes of the SDLAC meeting, including the agenda are available in the Deputy Commissioner's Office and that he had already requested the Deputy Commissioner's office in writing to provide the copy of the same to the appellant Shri Waris Alam Ansari. The appellant Shri Waris Alam Ansari however claimed that he does not remember receiving the letter of the Circle Officer written to the Deputy Commissioner's Office.
4. **In view of the above, the SPIO & Circle Officer, Bihpuria Revenue Circle, is directed to provide the appellant Shri Waris Alam Ansari with one more copy of the letter sent to the Deputy Commissioner's Office requesting to provide the appellant copy of minutes of the SDLAC meeting and Agenda list etc at the earliest. The Circle Officer is also directed to follow up the matter with the Deputy Commissioner's Office so that the appellant is furnished with the informations sought at the earliest. The appellant is directed to approach the Deputy Commissioner's Office and seek the informations as referred to by the Circle Officer on the strength of the above mentioned letter of the SPIO & Circle Officer.**
5. With the above order, this 2<sup>nd</sup> Appeal is hereby disposed of.
