- 1. The appellant Md. Faruk Ahmed is present.
- 2. Dr. Sumona Roy, SPIO and Joint Director, SCERT and Shri Hemanta Narayan Das, ASPIO, SCERT, Govt. of Assam, Guwahati are present. The SPIO also submitted a written statement No. SCERT/B/plan/RTI/43/2019/200 dated 17.02.2022, giving details of the informations provided against the appellant Md. Faruk Ahmed's RTI petition dated 27.09.2019. It also contains as attachment copies of the information furnished to the appellant. Regarding delay in furnishing the informations the SPIO said that while the pandemic situation had stood in the way of timely disposal of the RTI petition, there are also some third party information which took time for obtaining permission for sharing. The appellant Md. Faruk Ahmed on his part said that though he had received most of the information sought only on 17.02.2022, he expressed his dissatisfaction over delay in disposal of his RTI petition. He also said that since he has received most of the information sought, he is no longer interested in pursuing the matter and verbally requested for closure of the case. Hence this case is closed.
- 3. In view the above order, this 2^{nd} Appeal is hereby disposed of.
