O R D E R 18-02-2022

1. The appellant Shri Sourav Karmakar is absent without any intimation.

- 2. The SPIO, Dibrugarh University is absent. But the Commission has received a written statement dated 15.02.2022 from the PIO, Dibrugarh University, which contains information provided to the appellant.
- From perusal of records it is seen that the appellant Shri Sourav Karmakar had submitted an RTI
 petition to the PIO, Dibrugarh University, on 02.02.2021 seeking information regarding whether there
 is any record in the University of 2016 bearing Enrollment No. DU/BTCS/5436588.
- 4. On 16.03.2021, the PIO, Dibrugarh University vide letter No. DU/RG/PILO/B/5831 had informed the appellant Shri Sourav Karmakar that no record of the Enrollment No. DU/BTCS/5436588 has been found in the University. The PIO, Dibrugarh University, in his written statement also submitted photocopy of an e-mail sent by the appellant Shri Sourav Karmakar to the Law Officer, Dibrugarh University, a copy of which was marked to the Commission stating that since he had already received the information as such he does not want to pursue the matter further.
- 5. In view the above order, this 2nd Appeal is hereby disposed of.
