1. The appellant Shri P.C. Das is absent. But he has sent a letter to the Commission on 11.02.2022, informing about his inability to attend the hearing due to health problems.
2. The Public Authority is represented by Dr. Makhan Ch. Kalita, SPIO, Sub-Divisional Medical and Health Officer and accompanied by Shri Dhrubajyoti Patra, Birth and Death i/c, O/o the Gaurisagar BPHC. During today's hearing Dr. Makhan Ch. Kalita, also submitted a written statement to the Commission.
3. From perusal of records it is seen that the appellant Shri P.C. Das had sought information regarding whether the death certificate of one late Kanaklata Das, who expired on 08.02.2020, has been issued to one Smti Prasanna Mayee Das.

5. **In view of the above the SPIO, Dr. Makhan Ch. Kalita is directed to provide the information sought by the appellant Shri P.C. Das within 1 (one) week of the receipt of this order.**
