**O R D E R**  
**28-03-2022**

1. The appellant Shri Niranjana Medhi vide e-mail dated 27.03.2022 informs the Commission that he is unable to attend the hearing for his illness.
2. Md. Abdur Rahman Choudhury, Asst. Executive Engineer, O/o the Executive Engineer, PWD (NH), Construction Division, Abhayapuri, and SPIO is present. Shri Tikendra Nath Das, Asstt. Engineer and Shri Surajit Talukdar, Sr. Assistant, O/o the Superintending Engineer, PWD (NH Circle) Nalbari are also present as authorized by the Superintending Engineer and FAA.
3. **Seen the case records Shri Niranjana Medhi submitted one application dated 21.09.2021 under the RTI Act, 2005, before the SPIO of PWD (NH) Construction Division, Abhayapuri seeking some informations. He did not receive the informations within the stipulated period of time for which he submitted 1<sup>st</sup> Appeal petition dated 25.10.2021 before the First Appellate Authority of PWD (NH) Circle Nalbari. Mean while the Executive Engineer, NH, Abhayapuri, furnished the informations vide its letter No. 676 dated 29.11.2021. The first point of the applicant is not part of record to be maintained in the O/o the Executive Engineer, PWD (NH), Abhayapuri. The Executive Engineer, PWD (NH) informed the appellant to inspect the record of information sought through point No. 3 of the application and copies thereof can be collected on payment. The Executive Engineer sought for photocopying cost after elapse of 30 (thirty) days from the date of application which is not admissible. Therefore the appellant is directed to inspect the record of the sought for information of points No. 3 and take required copies thereof. The SPIO, o/o the Executive Engineer PWD (NH), Abhayapuri will invite the appellant within 7 (seven) days of receipt of this order on a mutually convenient date and facilitate for inspection of the records and give photocopies of the same free of cost. The whole process of inspection and furnishing of information should be completed within 2 (two) days from the date of start.**
4. With the above direction the 2<sup>nd</sup> Appeal dated 29.01.2022 is disposed of.
