1. The appellant Shri Durgeswar Das is absent.
2. The BDO and FAA of Barhampur Development Block, P.O. Barhampur, Distt. Nagaon, submits a written statement vide letter No. BDB/MISC./69/2015-16/179 dated 25.03.2022.
3. Seen the case records. Shri Durgeswar Das submitted one application dated 08.02.2018 under the RTI Act, 2005 before the SPIO of Barhampur Development Block seeking some informations. He did not receive the information within the stipulated period of time and submitted 1<sup>st</sup> Appeal petition dated 15.03.2018 before the FAA of Barhampur Development Block. Still he did not receive the desired informations & no action is seen to have been taken by the FAA, for which the petitioner submitted a 2<sup>nd</sup> Appeal dated 25.05.2018 before the Commission. It is submitted that the sought for informations had already been furnished to the appellant. However he does not have any objection for not receiving the information of point No. 8 and so requests the Commission to dispose of the appeal petition dated 25.05.2018.
4. Since the sought for informations had been already furnished to the appellant and the appellant also requests the Commission to dispose of the appeal petition, therefore this 2<sup>nd</sup> Appeal dated 25.05.2018 is disposed of.
