- O R D E R 21-03-2022
- The appellant Shri Jibeswar Kalita is absent. But the Commission has received a letter from him dated 16.03.2022 informing that he has received the informations from the SPIO, O/o the District Elementary Education Officer, Golaghat on 11.03.2022. He has also requested the Commission "to stop the case for the time being" in order to enable him to verify the documents.
