- 1. The appellant Shri Dadul Bharali is absent. But the Commission has received a letter from him by e-mail today stating his inability to attend the hearing due to physically indisposition.
- 2. Shri Boktar Ali, SPIO and Administrative Officer, Deputy Commissioner's Office, Darrang, and Shri Kamal Jeet Sarma, O/o the Circle Officer, Sipajhar Revenue Circle, are present.
- The SPIO has also submitted a written statement dated 10.03.2021 comprising 4 (four) pages. The Commission has also received a letter dated 10.03.2022 from the FAA and Addl. Deputy Commissioner, Darrang, authorizing Shri Boktar Ali to appear in today's hearing.

From records it is seen that the appellant Shri Dadul Bharali had submitted one RTI application on 12.04.2021 to the SPIO, O/o the Deputy Commissioner, Darrang seeking certain informations related to brick kilns in Bahgora, Dumunichowki, Mangaldoi under Dumunichowki Block. The SPIO in his written statement has referred to a letter of the then Circle Officer, Sipajhar, dated 04.01.2022, in which it was clearly stated that there is neither any Block office at Dumunichowki nor any village by the name of Bahgora under Sipajhar Revenue Circle, and hence reply could not be given against the RTI Application.
- 5. In view of the above, this 2<sup>nd</sup> Appeal is hereby disposed of without any order.
