<u>O R D E R</u> 10-03-2022

- 1. The appellant Shri Bibison Teron is present.
- 2. Shri Roling Ingti, SPIO and Asstt. BDO, Samelangso ITDP Dev. Block, Samelangso, Karbi Anglong, is present. He has also submitted a written statement dated 09.03.2022.
- 3. Records show that the appellant had submitted one RTI application to the PIO, O/o the BDO, Samelangso ITDP Dev. Block, Samelangso, on 02.07.2021, seeking informations under six points related to PMAY-G schemes for construction of houses at 4 villages under the block. On 10.08.2021 he submitted a 1<sup>st</sup> Appeal, following which the FAA and Project Director, DRDA, Karbi Anglong, held a hearing on 18.08.2021 and directed the SPIO, O/o the BDO, Samelangso ITDP Dev. Block, Samelangso, to provide the informations to the appellant within 7 (seven) days.
- 4. On 24.09.2021 Shri Bibison Teron submitted a 2<sup>nd</sup> Appeal in this Commission. During today's hearing the SPIO, Shri Roling Ingti stated that the appellant has been provided the information on 24.08.2021 by post. The appellant stated that he had indeed received them but have not received information related to query No. 5 and No. 6 of his RTI application. The SPIO, Shri Roling Ingti said that the informations related to query No. 5 and 6 have been prepared and ready for furnishing. In view of this, the SPIO is directed to provide the informations related to query No. 5 and 6 within 7 (seven) days from the date of receipt of this order, free of cost
- 5. With the above order, this 2<sup>nd</sup> Appeal is hereby disposed of.
