<u>O R D E R</u> 07-03-2022

- 1. The appellant Shri Dhanjeep Prasad Rabha is absent without any intimation. But he was contacted over telephone and heard.
- 2. Shri Tapash Nath, SPIO, Tax Collector, Goalpara Municipal Board, Goalpara, is present. He has also submitted a written statement No. GMB/RTI/Pt.I/2019/384 dated 05.03.2022 in which it has been stated that the information was provided to the appellant on 27.07.2021 against his RTI application dated 28.06.2021, and it was duly acknowledged by the appellant. It has been also stated that the Public Authority (Executive Officer, Goalpara Municipal Board) assumed that the applicant was satisfied with the information.
- 3. During today's hearing however the appellant said over telephone that he was yet to received one portion of the information sought under query No.1 of his RTI application, it being an expenditure statement of Goalpara Municipal Board. The SPIO present admitted that this information is yet to be provided and assured that the same would be furnished to the appellant immediately after the ongoing Municipal Board ongoing process is completed.
- 4. In view of this the SPIO is directed to furnish the pending information to the appellant within 15 (fifteen) days from the date of receipt of this order.
- 5. With the above order, this 2<sup>nd</sup> Appeal is hereby disposed of.
