ORDER 07-03-2022

- 1. The appellant Shri Harinarayan Pathak is present.
- 2. Shri Akhil Narayan Baruah, SPIO, i/c Administration & Deputy Manager, ASIDC Ltd. and Shri Ratul Kumar Mahanta, i/c Construction Division and Asstt. Engineer, ASIDC Ltd, are present.
