O R D E R 04-03-2022

1. The appellant Md. Abdur Rahim is present.

- 2. Md. Obaidulla, Headmaster, Burigaon M.E. School and Shri Gajiur Rahman, President, SMC, Burigaon M.E School, Distt. Darrang are present.
- The Head Master, Burigaon M.E. School, has submitted a written statement No. BMES/03/2021 dated 03.03.2022. The Commission has also received a statement No. DAN/RTI-9/2022/8 dated 17.02.2022 from the FAA, O/o the Deputy Commissioner, Darrang.
- From perusal of records it is seen that the appellant Md. Abdur Rahim had submitted one RTI application to the PIO, O/o the Head Master, Burigaon M.E. School, Darrang, on 24.06.2021 (sent by registered post 24.06.2021) seeking certain informations related to mid-day meals, uniforms, admission and examination fee of students of the School from 01.01.2018 to 01.06.2021. On 24.07.2021 he submitted a 1st Appeal in the O/o the Deputy Commissioner, Darrang. On 23.08.2021 the PIO, O/o the Deputy Commissioner, Darrang, transferred the Appeal to the Inspector of Schools, Darrang, and also to the PIO, O/o the Head Master, Burigaon M.E. School, Darrang, with a request to the petitioner Md. Abdur Rahim, to approach the PIO concerned. The Head Master, Burigaon M.E. School, Darrang, in his written statement has attached a copy of his forwarding letter to Md. Abdur Rahim with which he had provided him 112 (one hundred twelve) pages of information as requested. During today's hearing the appellant Md. Abdur Rahim however claimed that he had not been provided all the information he had sought. On examination of the informations (112 pages) which the appellant Md. Abdur Rahim displayed before the Commission, it was seen that he had been provided with all the information sought. The appellant however said that he had wanted details of funds received from the government for the schemes of which he sought the informations. On examination of the original RTI petition dated 24.06.2021 it was found that he had not requested for any specific financial details.
- 5. In view of the above, this 2nd Appeal is hereby disposed of.
