<u>O R D E R</u> 04-03-2022

- 1. The appellant Shri Harinarayan Pathak is present.
- 2. The SPIO, O/o the Engineer i/c Central Workshop and Manager, Industrial Estate, Bamunimaidam, Guwahati, is absent. But the Commission has received a written statement from the APIO, O/o the Engineer i/c Central Workshop and Manager Industrial Estate, Bamunimaidam, Guwahati, No. CWG (E)747/2009/part-I/652 dated 07.02.2022 stating that the informations sought by Shri Harinarayan Pathak vide his RTI application dated 01.02.2021 have been already furnished and that the appellant Shri Harinarayan Pathak has collected the same personally and had acknowledged receipt with signature on 20.02.2021. A photocopy of the forwarding letter containing acknowledging signature of the appellant Shri Harinarayan Pathak has been also provided in the written statement.
- 3. The appellant Shri Harinarayan Pathak however has submitted a letter dated 14.02.2022 to the Commission complaining that the informations provided to him are incomplete and unsatisfactory. He also pointed out that a letter No. CWG(E)747/2009/Part-I/ dated 08.03.2021 relating to hearing held by the FAA in the O/o the Enginereer i/c Central Workshop and Manager Industrial Estate, Bamunimaidam, Guwahati, (copy of which was submitted by the SPIO to the Commission along with the written statement) and said that the 1st Appeal hearing mentioned there is not related to his RTI application dated 01.02.2021 but to another RTI application. On the basis of these discrepencies, the appellant Shri Harinarayan Pathak alleged that the APIO has provided false and misleading information to the Commission.
- 4. In view of the above, and having perused the written statement of the APIO, O/o the Enginereer i/c Central Workshop and Manager Industrial Estate, Bamunimaidam, Guwahati, the Commission directs the APIO (i) to re-examine the RTI petition of Shri Harinarayan Pathak dated 01.02.2021 and provide him the remaining information, if any, and (ii) also clarify on the letter No. CWG(E)747/2009/Part-I/ dated 08.03.2021 and the accompanying page related to hearing before the FAA on 23.03.2021.
- 5. This order shall be carried out within 21 (twenty-one) days from the date of receipt of this order.
- 6. With the above order, this 2nd Appeal is hereby disposed of.
