<u>O R D E R</u> 22-03-2021

- 1. The appellant Md. Amir Hussain is present.
- Shri Nripendra Mohan Das, FAA and Executive Engineer, Mangaldoi Division (Iriigation), is present. The Commission had also received copy of a letter No. W/258/2021/458(A) dated 11.03.2021, written by Executive Engineer to the appellant Md. Amir Hussain, being forwarding letter of informations furnished to him in 25 (twenty-five) pages.
- 3. During the hearing today the appellant Md. Amir Hussain said that he has received the above-mentioned informations from the Public Authority, but some portions of the informations sought were still pending. The Executive Engineer, Shri Nripendra Mohan Das said that informations relating to query No. (a) of the RTI application was voluminous in nature and said that the appellant may inspect the same in his office.
- 4. In view of the above, the Executive Engineer, Mangaldoi Division, is directed to provide the remaining informations as pointed out by the appellant within 15 (fifteen) days from the date of receipt of this order, free of cost. Regarding query No. (a) of the RTI application, the Executive Engineer is directed to invite the appellant Md. Amir Hussain for an inspection of the voluminous documents in his office on a mutually agreed date and facilitate inspection of the same. The Executive Engineer is also directed to furnish photocopies of the pages of documents selected by the appellant, first 100 pages free of cost and the remaining pages by realising photocopying charges as applicable from the appellant within 15 (fifteen) days from the date of receipt of this order.
- 5. With the above order this 2<sup>nd</sup> Appeal is hereby disposed of.
