ORDER 18-03-2021

- 1. The appellant Shri Ismail Hussain is present.
- 2. The SPIO, O/o the District Elementary Education Officer, Darrang, Mangaldoi, Assam is absent without any intimation. The hearing has been taken up despite the absence of the SPIO.
- 3. From perusal of records, it is seen that the appellant Shri Ismail Hussain had submitted an RTI application before the SPIO, O/o the District Elementary Education Officer, Darrang, Mangaldoi, on 18.09.2020, seeking 11 (eleven) different informations related to the Galandi Tea Estate Primary School, under Dalgaon Siyalmari Block. On 28.10.2020, he submitted an Appeal before the FAA, O/o the District Elementary Education Officer, Darrang, Mangaldoi. A hearing was held on his 1st Appeal on 02.11.2020, in which the appellant claimed both he and the Head Master of the said School were present. The appellant stated that while the Head Master was verbally directed by the District Elementary Education Officer, Darrang, to furnish the informations to the appellant, the FAA however did not pass any written order on the matter. The appellant also stated that he was asked to collect the informations directly from the Head Master of the said School. He also said that a copy of the written order was not provided to him till date.
- 4. In view of the above, the SPIO, O/o District Elementary Education Officer, Darrang, Mangaldoi, is directed to ensure that the appellant Shri Ismail Hussain is furnished with the informations sought for in his RTI application dated 18.09.2020, within 21 (twenty-one) days from the receipt of this order. The SPIO is also directed to inform the Commission about action taken in this regard.
- 5. With the above order, the 2nd Appeal is hereby disposed of.
