



- 2. The SPIO, O/o the District Social Welfare Officer, Cachar, Silchar is absent. But the Commission has received a letter No. DSWO©24/RTI/PT-I/2019/ dated 06.03.2021, from the District Social Welfare Officer, informing that Sakhi One Stop Center, Cachar is independently run by the Center Administrator under direct supervision of the District Administration, Cachar, and all records and registers pertaining to the Sakhi One Stop Center is under custody of the Center Administrator. In view of this the District Social Welfare Officer has requested the Commission to issue direction to the Center Administrator, Sakhi, One Stop Center, Silchar.
- 3. In view of the above, the Center Administrator, Sakhi One Stop Center, Silchar, Cachar, is directed to furnish the informations sought by the appellant Shri Sayeed Hussain Mazumder through his RTI application dated 25.06.2020, within 21 (twenty-one) days from the receipt of this order. The information shall be provided free of cost. The Center Administrator, Sakhi One Stop Center, Silchar is also directed to submit an Action Taken Report on this order at the earliest.
- 4. The Deputy Commissioner, Cachar, Silchar shall take necessary action to ensure that the informations are furnished to the appellant Shri Sayeed Hussain Mazumder by the Center Administrator, Sakhi One Stop Center, Silchar, which is under direct supervision of the District Administration.
