- 1. The appellant Smti Rahila Narzary, is present.
- 2. The SPIO, O/o the Animal Husbandry & Veterinary Deptt., Bodoland Territorial Council, Kokrajhar, is absent without any intimation.
- 3. Dr. Dilip Kr. Bhuyan, Addl. Director (HQ) and FAA, Veterinary Deptt. Government of Assam, is present.
- 4. From perusal of records, it is seen that the appellant Smti Rahila Narzary had submitted an RTI application on 19.12.2019, to the PIO, Animal Husbandry & Veterinary Department, BTC, Kokrajhar, seeking certain information and documents related to the service of her husband Late Mantu Brahma, an M.R. worker of the Department who had died on 11.08.2005.
- 5. Dr. Dilip Kr. Bhuyan, during his deposition submitted a written statement and stated that Late Mantu Brahma, husband of appellant Smti Rahila Narzary, had joined as M.R. worker in the Department on 31.05.2001. The Government had vide Office Order No. A5/587/pt-A/2004-05/5702-6852 dated 01.10.2005, regularized 923 numbers of Grade IV posts in the Department and regularized the services of the M.R. workers who were continuously working without break w.e.f. 22.07.2005. While the Office Order was issued on 01.10.2005, Mantu Brahma, husband of the appellant Smti Rahila Narzary, had died due to snake bite on 11.08.2005, and thus obviously could not join as a permanent employee because of the time gap between the date of his death and the date of the issue of the said order.
- 6. In view of the above, the SPIO is directed to provide the informations sought by the appellant Smti Rahila Narzary within 15 (fifteen) days from the receipt of this order and inform the Commission accordingly.
- 7. With the above order the 2nd Appeal is hereby disposed of.
