**O R D E R**

**02-05-2022**

1. The appellant Jitu Roy is present. He is assisted by Shri Upakul Choudhury, S/o Janardan Choudhury (He has submitted photocopy of his driving licence as identity card).
2. The SPIO, O/o the Assam State Electricity Board, Bijulee Bhawan, Paltan Bazar, Guwahati, is absent without any intimation.
3. During today's hearing, which was conducted despite the absence of the SPIO, the appellant Shri Jitu Roy stated that while he had received most of the informations, some were not provided, for which he was asked by the SPIO to deposit Rs. 12 (twelve) only as photocopying charges. But he has not received the informations even after he deposited the amount for photocopying charges on 26.04.2021. He sent a 1<sup>st</sup> Appeal to the FAA, ASEB, Bijulee Bhawan by registered post on 27.07.2021. The appellant displayed the returned consignment during the today's hearing and also provided a photocopy of the same.
4. In view of the fact that the SPIO, ASEB, Bijulee Bhawan is absent in today's hearing, fix **23.05.2022 at 12:00 PM.** as the next date of hearing. The SPIO, ASEB, Bijulee Bhawan, is directed to remain present in the date of hearing.
