- 1. The complainant Shri Biswanath Kundu is absent. But he has sent a letter to the Commission dated 04.03.2022 in which he has expressed his inability to attend the hearing in person. He has also requested for virtual hearing.
- The SPIO and Circle Officer, Dhubri Revenue Circle is absent. But the Commission has received a written statement No. DBC.33.2014/Pt-III/30 dated 14.02.2022 informing the Commission that the informations sought by Shri Biswanath Kundu vide his RTI application dated 01.07.2021 has been already furnished vide letter No. DBC.33.2014/Pt-I/312 dated 09.09.2021, DBC.33/2014/Pt-I/340 dated 02.11.2021 and DBC.33/2014/Pt-I/242 dated 31.07.2021.

- 4. The appellant Shri Biswanath Kundu has also submitted a complaint against the Public Authority in connection with his RTI application.
- 5. Since it is not possible to clarify on the various issues on the written statement/complaint submitted by Shri Biswanath Kundu and since the SPIO/Circle Officer, Dhubri Revenue Circle, is not present, hence fix 24.05.2022 at 11:20 AM as the next date of hearing. BothSPIO/Circle Officer, Dhubri Revenue Circle, and the appellant Shri Biswanath Kundu shall physically remain present on the date of hearing.
- 6. This order shall constitute the notice of hearing.
