O R D E R 02-05-2022

1. The appellant/complainant Shri Jamini Kr. Doley is present.

- 2. The SPIO, O/o the BDO, Murkongselek T.D. Block, Jonai, Assam, is absent without any intimation. The hearing was taken up despite the absence of the SPIO, as the appellant/complainant has travelled all the way from Jonai.
- 3. From perusal of records it is seen that the appellant/complainant Shri Jamini Doley had submitted one RTI application to the SPIO, O/o the BDO, Murkongselek T.D. Block, Jonai, Assam, on 31.07.2018 and has since been running from pillar to post for getting the information sought. On 04.09.2019 the Commission had vide its order directed the SPIO/BDO, Murkongselek T.D. Block, Jonai, Assam, to facilitate procurement of information sought by the appellant/complainant Shri Jamini Doley. On 03.10.2020 Shri Jamini Doley complained to the Commission that he has not been furnished the information despite the Commission's order and despite requesting the BDO, Murkongselek T.D. Block, Jonai, Assam, several times. On 24.03.2021 the Commission had directed the SPIO, Murkongselek T.D. Block, Jonai, Assam, to submit an Action Taken report on the Commission's order dated 04.09.2019. More than 11 (eleven) months have passed and there has been no response to the Commission's letter No. SIC/DMJ.16/2019/31 dated 24.03.2021 asking the SPIO to submit the Action Taken Report.
- 4. Since the SPIO, Murkongselek T.D. Block, Jonai, Assam, is absent without any information today, hence fix 25.05.2022 at 11:00 AM as the next date of hearing. The SPIO, Murkongselek T.D. Block, Jonai, Assam, is directed to personally appear in the next hearing without fail and also submit a written statement expressing why penalty under Section 20(1) shall not be imposed on him/her and or disciplinary action not recommended against him/her for his/her failure to furnish the sought for information despite a clear order from the Commission. A Copy of this order be marked to the Project Director, DRDA, Dhemaji, and to the Commissioner, P & RD Department, Govt. of Assam for information.
- 5. This order shall constitute the notice of hearing.
