O R D E R

1. The appellant Md. Tousif Hussain Reza is present.

- 2. Shri Chinmoy Neog, Circle Officer (Attached), Dispur Revenue Circle, is present. He has also submitted a written statement signed by the SPIO, Dispur Revenue Circle, Guwahati. The Circle officer (A) Dispur Revenue Circle too has submitted a written statement dated 22.03.2022.
- 3. From records it is seen that the appellant Md. Tousif Hussain Reza had submitted one RTI application to the SPIO, Dispur Revenue Circle, Guwahati, on 15.09.2021 requesting for certain informations related to land under dag No. 41 (Old)/281/ (New), Patta No. 1 (Old)/385 (New) of Revenue Village-Jyotikuchi, Dhopolia, Mouza-Beltola, Dispur Revenue Circle, Kamrup (Metro). On 11.10.2021 he submitted a 1st Appeal and on 15.11.2021 he submitted a 2nd Appeal before this Commission. During today's hearing Circle Officer (A), Shri Chinmoy Neog stated that the informations sought had been already provided to the appellant on 22.12.2021 and 02.02.2022. A copy of the informations furnished has been enclosed along with the written statement of the Circle Officer (A), Dispur Revenue Circle. The appellant however said that he had not received any of the informations as stated by the Circle Officer.
- 4. In view of the above, the SPIO/Circle Officer, Dispur Revenue Circle is directed to once again furnish the information against RTI application of 15.09.2021 within 21 (twenty-one) days from the date of receipt of this order, free of cost and obtain an acknowledgement receipt.
- 5. With the above order this 2nd Appeal is hereby disposed of.
