1. The petitioner Sri Manoj Das has filed his RTI application on 16.12.2021 before the SPIO, O/o the Assam Seeds Corporation Ltd., Khanapara, Guwahati seeking following information:

(a) Name and copies of work order/supply order for supplying of sunflower seeds?

- (b) Details of the tender with name of each bidder.
- (c) How much amount has been released so far with details?
- (d) Name of the Company from where the seeds have been purchased? Copies of Challan and bill voucher.
- (e) Details of seed gadget notification (in pendrive), Trial Report in pendrive.
- (f) Seed Directories, Source of Seed, and Source in the bill.
- (g) How much amount of seeds released to each districts?
- (h) Copies of district wise APR(Actual Payment Receipt).
- On non-receipt of any information, the petitioner filed 1st appeal before the 1st Appellate Authority, O/o the Assam Seeds Corporation Ltd on 19.1.2022 and then he filed 2nd appeal before the Commission on 3.3.2022.

Accordingly, the matter was taken up for hearing.

- 3. The petitioner Sri Manoj Das is present.
- 4. The Public Authority to be represented by SPIO, O/o the Assam Seeds Corporation Ltd. is absent. However, the Deemed PIO has sent an email dated 18.5.2022 wherein he has mentioned that sought for information has already been furnished to the petitioner on 13.5.2022.
- 5. The petitioner also submitted a letter dated 18.5.2022 wherein he has mentioned that he has received the information from Assam Seeds Corporation Ltd.
- 6. In view of the above, the case is disposed off .
