ORDER 18/05/2022

- 1. The petitioner Sri Gaurav Kumar Choudhury has filed one complaint petition addressed to Honourable CM of Assam on 6.9.2021 and then he filed RTI petition before the SPIO, General Administration Dept. Block A, 2nd floor, Janata Bhawan, Dispur, Guwahati 6 on 29.12.2021 seeking information regarding status of the complaint petition.
- The SPIO & Under Secretary to the Govt. of Assam, General Administration Department forwarded the RTI application to the SPIO of Revenue & Disaster Management (Settlement) Department, Assam Secretariat. Vide letter no. GAG(A)89/2021/60 Dated Dispur 5th January 2022.
- The Joint Secretary to the Govt. of Assam, Revenue & Disaster Management Department Dispur forwarded the RTI petition to the Deputy Commissioner, Kamrup (M) vide letter no. ECF No. 205633/2022/23 Dated Dispur 27th April,2022 for taking necessary action.

However, the petitioner was not aware of it, so he filed 1st appeal before the First Appellate Authority, Revenue & Disaster Management (Settlement) Department, Assam Secretariat Dispur, Guwahati on 9.2.2022 and then he filed 2nd appeal before the Commission on 14.3.2022.

- Accordingly, the matter was taken up for hearing.
- 4. The petitioner Sri Gaurav Kr. Choudhury is present.
- 5. The Public Authority is represented by Ananda Kumar Das, SPIO, Revenue & Disaster Management Department, Dispur, Guwahati. The SPIO had submitted a brief note on the action taken report.
- 6. From the above, it is seen that the RTI petition is duly been forwarded to the Deputy Commissioner, Kamrup (M) for taking necessary action.
- 7. Therefore, the Commission directs the SPIO, O/o the Deputy Commissioner, Kamrup Metro to take suitable necessary action and intimate the petitioner about the same.
- 8. The Joint Secretary to the Govt. of Assam, Revenue & Disaster Management Department is also directed to send a reminder letter to the Office of the Deputy Commissioner, Kamrup (Metro) with a copy to the petitioner.
- 9. In view of the above, the case is disposed off.
