ORDER 18/05/2022

- 1. The petitioner Sri Manoj Das has filed his RTI application before the SPIO, O/o the Commissionerate of Panchayat and Rural Development on 29.12.2021 seeking following information:
 - (a) Specify in details; the procedure under which Mr. Apurba Baruah was appointed as BDO (Bejera Dev. Block) and also appointed as the Executive Engineer of District Rural Development Agency – Kamrup.
 - (b) Specify in details; Under what condition and qualification Mr Apurba Baruah was appointed as Executive Engineer of DRDA – Kamrup. Kindly furnish the copies of:
 - (i) Adv. For the post before appointment.
 - (ii) Selection procedure.
 - (iii) Letter of appointment.
 - (c) Specify in details; What are the established procedure and Govt. guideline mentioned at the time of appointment of Mr. Apurba Baruah as Executive Engineer.
- On non receipt of any information, the petitioner filed 1st appeal before the 1st Appellate Authority, Commissionerate of Panchayat and Rural Developmentj, Juripar, Panjabari Road, Guwahati on 2.2.2022 and then he filed 2nd appeal before the Commission on 14.3.2022.
 - Accordingly, the matter was taken up for hearing.
- 3. The petitioner Sri Manoj Das is present.
- 4. The Public Authority to be represented by SPIO, O/o the Commissionerate of Panchayat and Rural Development, Panjabari, Guwahati is absent. However, the Joint Commissioner of Panchayat & Rural Development, Panjabari, Guwahati has submitted a written statement vide letter no. CPRD/RTI/122/2021/40 dated 10.5.2022 which is taken into records.
- 5. The Joint Commissioner has enclosed a copy of letter vide no. PRD-12028/1/2020-PRD(B)/25 dated 12.3.2021 which is sent by the Additional Secretary to the Govt. of Assam, Panchayat & Rural Development to the petitioner Sri Manoj Das giving the details of Government orders regarding posting of Mr Apurba Baruah. It is seen from the letter that it has been sent through registered post to the petitioner.
- 6. At the hearing, the petitioner has said that he has not received a copy of the reply.
- 7. In light of it, the Commission orders that the copy of the letter along with the enclosures be provided by the Additional Secretary, Panchayat & Rural Development Deptt. to the petitioner within fortnight.

The petitioner may also visit the Office of Additional Secretary to the Govt. of Assam, Panchayat & Rural Development Deptt and collect

the photocopies, to which the Additional Secretary of Panchayat & Rural Development will facilitate.

8. In view of the above, the case is disposed off.
