**O R D E R**  
**02/06/2022**

1. The petitioner Sri Kirtikamal Bora has filed a RTI petition before the PIO, O/o the Director General of Police, Dr.B.K.Kakati Road, Ulubari 07 on 16.02.2022 seeking five numbers of information in Assamese whose rough translation in English is given as follows.
  - (a) Educational qualification submitted by Rajib Dutta during working as Assistant Engineer in Assam Police Headquarters
  - (b) Copy of appointment letter given to Assistant Engineer Rajib Dutta.
  - (c) Name and address of the Engineering Institute and copies of admission fee receipts submitted by Assistant Engineer Rajib Dutta during admission in Engineering Institute.
  - (d) Copies submitted by Assistant Engineer Rajib Dutta having proof of working or not working in other official Establishments.
  - (e) Copies of Government permission given to Assistant Engineer Rajib Dutta for foreign travels.
2. The petitioner then filed 1<sup>st</sup> appeal before the PIO, O/o the Director General of Police, Dr.B.K.Kakati Road, Ulubari 07 Guwahati on 4.4.2022 and after that he filed 2<sup>nd</sup> appeal before the Commission on 11.4.2022.

Accordingly, the matter was taken up for hearing.
3. The petitioner Sri Kirtikamal Bora is present.
4. The Public Authority is represented by Dr. D.P.Ghanwat, IPS, Assistant Inspector General of Police(A) & SPIO, Assam Police Headquarters, Ulubari, Guwahati.
5. The PIO has submitted a written statement dated 31.5.2022 which is taken into records. In the written statement it is mentioned that the sought for information has already been furnished to the petitioner vide Headquarter Memo No. G(RTI)/VI/55/2022/7 dated 1.4.2022.

The petitioner said that no educational qualification certificate is furnished rather participation in drama certificate is enclosed. The Commission directs the SPIO to furnish the degree certificates to the petitioner.

6. The petitioner raised some points on fees deposit during degree education, to which the SPIO stated that they do not have any details on Academic fees receipt.
7. On perusal of the records, it was found that the petitioner whose four 2<sup>nd</sup> appeal cases were heard today, has filed this 2<sup>nd</sup> appeal on 11.4.2022 before the Commission without following the mandatory period of thirty days given to the 1<sup>st</sup> Appellate Authority, as he has filed 1<sup>st</sup> appeal petition on 4.4.2022.  
The Commission like to impress upon the petitioner to follow the provision of RTI Act, 2005 scrupulously without fail.

8. In view of the above, the case is disposed off.
