1. The petitioner Sri Kirtikamal Bora has filed one RTI petition before the PIO, O/o the Managing Director of Guwahati Smart City Limited, Govt. of Assam, Guwahati on 24.1.2022 seeking some information on Anytime Water Machine.
2. Reportedly on not getting any information, the petitioner filed 1<sup>st</sup> appeal before the First Appellate Authority, O/o the Managing Director of Guwahati Smart City Limited, Govt. of Assam, Guwahati on 1.3.2022

In reply to that, the SPIO of Guwahati Smart City Limited sent a reply to the petitioner on 28.3.2022.

3. The petitioner then filed 2<sup>nd</sup> appeal before the Commission on 18.4.2022 and accordingly the matter was taken up for hearing.
4. The petitioner Sri Kirtkamal Bora is present.
5. The Public Authority is represented by Ng. Chandra D Singha, SPIO & OSD, Guwahati Smart City Limited.
6. The SPIO of Guwahati Smart City Limited has submitted a written statement dated 31.5.2022 giving partial information.
7. On perusal of the reply, only seven ATM Water Machines are functional and the SPIO has given the photos of functional ATM Water Machines.

The petitioner says that photos of non-functional ATM Water Machine are not given and regarding installation photos, the SPIO says that those photos are not available with him.

8. The Commission accepts it and directs the SPIO to furnish the photos of non functional Anytime Water Machine to the petitioner.
9. In view of the above, the case is disposed off.
