O R D E R

1. The petitioner Sri Joydeb Das has filed one RTI petition before the PIO, District Commandant, Home Guards, Kamrup, Panikhati Guwahati on 14.2.2022 seeking following information:
 - (a) Please furnish list of how many number of home guards working without break and with break after six month in Indian Oil Corporation Ltd., Noonmati Guwahati 21 during the period 1st January, 2018 to till date.
 - (b) Please furnish list of how many number of home guard working without break and with break after six month in All India Radio during the period 1st January 2018 to till date.
2. The Assistant PIO & District Commandant of Home Guards, Panikhati, Guwahati then sent a reply to the petitioner on 14.3.2022 wherein it is mentioned that information relating to question no.1 and 2 have been exempted vide Govt. of Assam, Political (A) Deptt. Vide notification no. PLA.384/2005/55 dated 8.3.2006. Hence the information cannot be provided.
3. The petitioner then filed complaint petition u/s18(1) of the RTI Act,2005 before the Commission on 11.4.2022 and accordingly, the matter was taken up for hearing.
4. The petitioner Sri Joydeb Das is present.
5. The Public Authority is represented by Sri Basanta Sarma, District Commandant Home Guards, Kamrup.
6. The Commission accepts the exemption vide Government of Assam, Political (A) Deptt Vide notification no. PLA.384/2005/55 dated 8.3.2006. However, **while accepting the reply the Commission directs the District Commandant to submit a statement whether they are rotating after every six months or not.**
7. In view of the above, the case is disposed off.
