1. The petitioner Sri Ram Bachan Singh has filed one RTI petition before the PIO, O/o the Deputy Commissioner, Sonitpur, Tezpur on 17.1.2022 seeking following information:  
(a) Kindly provide me the certified copies of the rules, guidelines, circular or govt. order prohibiting approval of NOC for sale of land in case of litigation brought by third party in which there is no direction/ instruction/ order etc. from the court.
2. On non receipt of any information, the petitioner filed 1<sup>st</sup> appeal before the 1<sup>st</sup> Appellate Authority cum ADC, O/o the Deputy Commissioner, Sonitpur, Assam on 25.2.2022 and then he filed 2<sup>nd</sup> appeal before the Commission on 14.3.2022.  
Accordingly, the matter was taken up for hearing.
3. The petitioner Sri Ram Bachan Singh is present.
4. The Public Authority to be represented by SPIO, O/o the Deputy Commissioner, Sonitpur, Tezpur is absent.
