O R D E R 20/05/2022

- The petitioner Sri Nani Das has filed one RTI petition seeking eight numbers of information stressing over a period from 2013-2021 relating to Director, Animal Husbandry & Veterinary Dept., Guwahati, Assam from the SPIO(whom he addressed as 1st Appellate Authority, Kamrup (M), Assam) in his application dated 19.10.2021.
- 2. Since the matter relates to Animal Husbandry & Veterinary Department, the same was forwarded to SPIO of the office of Deputy Commissioner, Goalpara.
- 3. In the meantime, the petitioner filed his 2nd appeal petition before the Commission on 24.2.2022.

Accordingly, the matter was taken up for hearing.

- 4. The petitioner Sri Nani Das is present.
- 5. The Public Authority is represented by Smti Kalpana Deka, ACS, ADC & SPIO, Kamrup (M).
- 6. The petitioner stated that he was advised by someone, that if applies before the Deputy Commissioner, Kamrup (M) he will easily get the information from Animal Husbandry & Veterinary Dept., Guwahati.
- 7. The ADC & SPIO, Kamrup(M) said that since the matter relates to DC, Goalpara, a letter vide no. RTI/MISC.1/2019/236 dated 13.5.22 was forwarded for taking necessary action in furnishing the information.

However, the copy of this was not marked to the petitioner.

- 8. In light of it, the petitioner is advised to file a petition before the SPIO, Director, Animal Husbandry & Veterinary Department.
- 9. In view of the above, the case is disposed off.
