- **1.** In continuation of earlier order dated 17.3.2022, the matter was taken up for hearing.
- 2. The petitioner Sri Joydeb Das is present.
- 3. The Public Authority is represented by Sri Nimit Jain, Finance Advisor & SPIO, APFBCS.
- 4. In respect of query no.4, the petitioner said that details of condemnation procedure adopted prior to purchasing of new vehicles is not furnished to him and wanted to know what happened to vehicles allotted to those officers previously.

The Commission directs the SPIO to furnish the details of condemnation procedure to the petitioner within fifteen days.

At the same time, when new vehicles are allotted, whether those officers are without any vehicles previously or not, if they had allotted vehicles previously what happened to those vehicles, details of those vehicles should be given within fifteen days to the petitioner.

5. In view of the above, the case is disposed off.
