O R D E R 21/05/2022

- 1. The petitioner Sri S K Sarma has filed one RTI petition before the SPIO, O/o the Assam Mineral Development Corporation, Dispur, Guwahati on 18.12.2021 seeking some information.
- 2. On non receipt of any information, the petitioner filed a 1st appeal petition before the 1st Appellate Authority, O/o the AMDC, Dispur Guwahati on 3.2.2022 and then he filed 2nd appeal before the Commission on 15.3.2022.

Accordingly, the matter was taken up for hearing.

- 3. The petitioner Sri S K Sarma is present.
- 4. The Public Authority is represented by Amit Kumar, Mining Engineer.
- 5. The petitioner stated that he has not got any information and with his 2nd appeal petition he has enclosed a letter dated 20.12.2018 addressed to MD of Assam Mineral Development Corporation Ltd., Dispur Guwahati wherein he has mentioned certain points regarding enquiry report of Meghalaya government and the information given by Mr. G. Kharsati and these are not submitted with relevant documents.

The Commission asks him to provide supporting documents, if any.

- 6. At the same time, the SPIO said that they have already provided the reply to the RTI petitioner vide letter dated 27.1.2022 and letter says the exemption clause u/s 8(d) of RTI Act,2005 without giving any specific justification.
- 7. The Commission desires solid justification in case the exemption is to be accepted.
- 8. In light of it, the Commission desires to hear the matter again with proper explanation and supported documents from both the petitioner and the Public Authority.
- 9. Fix 27.6.2022 at 11:15AM as the next date of hearing.
