- 1. The petitioner Sri Joydeb Das has filed one RTI petition before the PIO of Assam Fishery Development Corporation Ltd. Guwahati 36 seeking following information:
 - (a) Please furnish in details (all the copy viz sanction post, advertisement, name of applied and selected candidate, appointment letter, minutes of the governing body and approval of finance department/Govt. of Assam) of recruitment of various post in AFDC during the period 2017-18 to till date.
- 2. On non-receipt of any information, the petitioner filed 2nd appeal before the Commission on 15.3.2022 and accordingly, the matter was taken up for hearing.
- 3. The petitioner Sri Joydeb Das is present.
- 4. The Public Authority is represented by Sri Himangshu Bora, Project Manager & SPIO, AFDC Ltd.
- 5. The SPIO said that he has furnished most of the replies except details relating to appointment letter, the SPIO was unable to furnish the information because of the absence of the Dealing Assistant in his office. However, he intimated that it will be provided to the petitioner directly.
- 6. The Commission directs the SPIO to provide the information within fifteen days from the date of receipt of the letter.
- In view of the above, the case is disposed off.
