### O R D E R 25/05/2022

- 1. The petitioner Sri Harinarayan Pathak has filed one RTI petition before the PIO of Revenue & Disaster Management Department, Dispur on 16.12.2021 seeking following information:
  - (a) Copy of the relevant documents as following together with the relevant enclosures (if any):
    - (i) No.RSG/19/2001/23, Dated 15.10.2003;
    - (ii) No.RSG/19/2001/84, Dated 27.11.2007
    - (iii) No.RSG/19/2001/107, Dated 23.02.2010
    - (iv) No.RSS/1370/2010/160, Dated 9.10.2013.
  - (b) Copy of file notings of file no. RSG.19/2001 from page 1n till date of furnishing the information.
- 2. On non receipt of any information, the petitioner filed 1<sup>st</sup> appeal before the 1<sup>st</sup> Appellate Authority, Revenue and Disaster Management Department, Dispur on 7.2.2022 and then he filed 2<sup>nd</sup> appeal before the Commission on 29.3.2022.

Accordingly, the matter was taken up for hearing.

- 3. The petitioner Sri Harinarayan Pathak is present.
- 4. The Public Authority is represented by Sri Ananda Kumar Das, ACS, Joint Secretary & SPIO, Revenue & Disaster Management Department.
- The SPIO has submitted a written statement dated 25.5.2022 where it is mentioned that documents that are currently available at the Department have been furnished.

However, copy of file noting of File no. RSG.19/2001 from Page 1N till date has not been furnished as it has not been traced out at the Branch till date.

Under Project Sadbhawana, categorisation process of older files has been going on at this department and if the file RSG.19/2001 is traced out through this process, it would be provided to the petitioner directly.

He also stated that the sought information regarding filed No. RSG.19/2001 is more than 20 years old.

- 6. The Commission accepts the written statement and directs the SPIO to take necessary steps in furnishing the file notesheet once the file is traced.
- 7. In view of the above, the case is disposed off.
