O R D E R 27/05/2022

- 1. The petitioner Sri Kirtikamal Bora has filed one RTI petition before the PIO, O/o the Chief Engineer of Public Health Engineering, Govt. of Assam, Japorigog Road, Lichubagan, Hengrabari, Guwahati on 29.11.2021 seeking some information as per the enclosures.
- 2. Reportedly on not getting any information, the petitioner filed 1st appeal before the 1st Appellate Authority, O/o the Chief Engineer of Public Health Engineering, Govt. of Assam, Hengragari, Guwahati on 3.1.2022 and then he filed 2nd appeal before the Commission on 28.3.2022.

Accordingly, the matter was taken up for hearing.

- 3. The petitioner Sri Kirtikamal Bora is present.
- 4. The Public Authority is represented by Sri Tapan Sharma, Executive Engineer (PHE), O/o the Chief Engineer(PHE) accompanied by Smti Deepshikha Shyam, AEE (PHE), O/o the Executive Engineer (PHE), Jorhat Division.
- From the records, it is seen that application was filed before the office of Chief Engineer (PHE) which was transferred to SPIO, O/o the Executive Engineer (PHE), Jorhat Division, Jorhat vide letter no. PHE-324/RTI/2019/22328 dated 21.12.2021.
- 6. The SPIO, O/o the Executive Engineer (PHE), Jorhat Divison intimated that she has sent the reply through DTDC courier, but the reply could not be delivered due to insufficient address and returned to their office on 18.2.2022. However, the SPIO has again sent the reply to the petitioner on 21.5.2022 vide letter no. PHEE/JOR/W-536(B)/2022-23/2227 dated 21.5.2022.
- 7. The petitioner said that he has received the 2nd letter but he needs some clarification like DIPR number of publications in the paper and some photocopies of reply to other two questions of the RTI petition.
- 8. The Commission directs the SPIO, O/o the Executive Engineer (PHE), Jorhat Division to send the relevant copies through registered post within fifteen days to the petitioner.
- 9. In view of the above, the case is disposed off.
