2. On not being satisfied with the information received, the petitioner filed 1<sup>st</sup> appeal before the 1<sup>st</sup> Appellate Authority, O/o the Commissioner of Police East, MG Road, Panbazar, Guwahati on 7.1.2022 and then he filed 2<sup>nd</sup> appeal before the Commission on 19.3.2022.
