1. The petitioner Sri Uttam Majumdar has filed one RTI petition before the Superintendent of Police, Nagaon on 31.1.2022 seeking following information:-  
G.D.E Extract Certified Copy of Nagaon Sadar P.S., P.S Case No. 802/21 dated 3.3.2021, Date of Accident 3.3.2021, in connection with MACT Case No. 1107/21, (Guwahati).  
The Registration number of vehicle involved in the accident along with the name of injuries and died persons, G.D.E. Extract Certified Copy, FIR/Azahar, MVI Report, Seizure List, Medical Report & PM Report etc. along with the vehicle particulars.
2. On non receipt of any information, the petitioner filed 1<sup>st</sup> appeal before the 1<sup>st</sup> Appellate Authority, O/o the Superintendent of Police, Nagaon on 15.2.2022 and then he filed 2<sup>nd</sup> appeal before the Commission on 28.3.2022.  
Accordingly, the matter was taken up for hearing.
3. The petitioner Sri Uttam Majumdar is absent. However, he has sent an email dated 27.5.2022 wherein he has mentioned that he has received the sought for information.
4. The PIO, O/o the Superintendent of Police, Nagaon has also submitted a written statement dated 18.5.2022 wherein he has mentioned that the sought for information has already been furnished to the applicant vide office memo No. IV/RTI/05/22/170 dated 17.3.2022.
5. Since the information is received, the case is disposed off.
