O R D E R 31/05/2022

- 1. The petitioner Sri Joydeb Das has filed one RTI petition before the PIO of Assam State Development Corporation for Scheduled Castes Ltd.,Guwahati on 27.1.2021 seeking following information:
 - (a) Please furnish in details of the statement of tender flouted for interest of welfare of scheduled castes community during the period 2016-17,2017-18,2015-19,2019-20,2020-21 and 2021-22, along with fund involved and released and copy of proposal, Govt. sanction letter, FOC, Bill and work order.
 - (b) Please furnish comment of Managing Director on district challans (duly signed) and beneficiaries share has been received prior released of payment to the suppliers.
 - (c) Please furnish whether Managing Director has taken any consent from Parent Administrative Department for implementation of above such scheme, if yes, please furnish a copy of the same.
- Reportedly on not getting any information, the petitioner filed 1st appeal before the First Appellate Authority, Assam State Development Corporation for Scheduled Castes Ltd., Kahilipara on 17.3.2022. And then he filed 2nd appeal before the Commission on 4.5.2022.

Accordingly, the matter was taken up for hearing.

- **3.** The petitioner Sri Joydeb Das is present.
- **4.** The Public Authority is represented by Sir Kirendra Chandra Das, SPIO & Administrative Officer, Assam State Development Corporation for Scheduled Castes Ltd., Sarumotoria, Dispur, Guwahati.
- 5. The SPIO has submitted a written statement dated 31.5.2022 stating that their office was shifted twice and they also had performance audit conducted by CAG because of which the information could not provided to the petitioner within stipulated time.

However, all the replies of the RTI petition is ready and he has brought with him.

- 6. Therefore, the Commission directs the SPIO to furnish the information to the petitioner today itself.
- 7. In view of the above, the case is disposed off.
