**O R D E R**  
**10-05-2022**

1. The appellant Sri Amzad Hussain Talukder is absent. But the Commission has received an e-mail from the appellant at 10:23 AM today stating his inability to attend the hearing as he has apparently received the notice of hearing only from a colleague of his, who had received it, on the previous day on his behalf. The appellant has requested for fixing another date. Records show that the Commission had tried to contact him more than once over the telephone on 28.04.2022 to inform him about today's hearing. The petitioner however had not received the phone on that day.
2. Shri Ahmed Ali, Head Master, Chitalmari M.E. School is present.
3. The hearing was taken up despite the absence of the appellant in the interest of the speedy disposal of case and making information available to the appellant.
4. Records show that this case was closed on 17.12.2021. But on 04.01.2022 the appellant sent an e-mail to the Commission saying that he had not received the information despite visiting the school two times, during which he allegedly found the Head Master absent. Since this is a serious complaint, the Commission decided to take up the matter for hearing again and hence today's hearing.
5. During today's hearing, Shri Ahmed Ali, Head Master, Chitalmari M.E. School, verbally stated that the informations have been kept ready for furnishing to the appellant as per the order (para 6) of this Commission dated 26.11.2020. The Head Master also submitted photocopy of a letter No. CMES/01/2021/28 dated 16.11.2021 written to the appellant Shri Amzad Hussain Talukder requesting him to visit the school and personally collect the informations and/or inspect the same as per the Commission's order of 26.11.2020. **In view of this, the appellant Shri Amzad Hussain Talukder is directed to visit the school on any working day within 7 (seven) days from the date of receipt of this order by fixing a prior appointment with the Head Master and collect the informations as per (para 6) of the Commission's order dated 26.11.2020.**
6. No further communication shall be entertained in this matter.
7. With the above order this 2<sup>nd</sup> Appeal is disposed of.
